Dear Bill Lynch Families:

I am writing to share that the New York City Department of Education (NYCDOE) has issued an Educational Impact Statement (EIS) proposing to expand the grades served by The William Lynch School (06M368), referred to as Bill Lynch, beginning in the 2024-2025 school year. Bill Lynch, which currently serves students in grades K-5 as well as in 3-K and pre-Kindergarten (pre-K) programs, will expand to also serve grades 6-8 if this proposal is approved.

Bill Lynch is currently co-located with P.S. 153 Adam Clayton Powell (06M153), referred to as P.S. 153, in the M153 building at 1750 Amsterdam Avenue, New York, NY 10031 in Community School District 6. M153 also houses the Community Based Organizations Boys and Girls Club of Harlem, Harlem Dowling, and The Harlem Hellfighters.

### **What is the NYCDOE proposing?**

The NYCDOE is proposing a grade expansion. If this proposal is approved by the Panel for Educational Policy (PEP), in addition to the grades and programs Bill Lynch already serves, it will also serve grades 6-8. The NYCDOE believes that this proposal presents an opportunity to create a community driven K-8 option to address the need for a progressive middle school option for families in District 6. This proposal will also enable Bill Lynch to continue building upon its existing strong culture by allowing students to remain in the same school through grade 8.

### **If this proposal is approved by the PEP, what does this mean for my child(ren)?**

- Bill Lynch will add sixth grade in the 2024-2025 school year and will continue to phase in one grade per year until it serves grades K-8 in the 2026-2027 school year and reaches full enrollment scale in the 2027-2028 school year.
- Current Bill Lynch students will be able to complete elementary and middle school in one school.
- This proposal is not expected to impact current or future student admissions or programming at Bill Lynch, a non-zoned District 6 elementary school that gives priority to students who live in District 6.
  - If this proposal is approved, Bill Lynch will admit students through the middle school admissions process with a priority for continuing fifth grade students enrolled in the school, then to applicant(s) whose siblings will be enrolled in the school next year.
  - Bill Lynch's middle school grades will only be open to District 6 students or residents.
- In the 2024-2025 school year, Bill Lynch will offer academic programming to middle school students, who will be able to take advantage of the many existing and anticipated new opportunities and partnerships accessible to current Bill Lynch students.
- Bill Lynch will continue to offer extra-curricular programs based on student interests, available resources, and staff support for those programs as it phases in their middle school grades.

**How can I provide feedback?**

In advance of the PEP vote, a Joint Public Hearing for this proposal will be held via teleconference on Wednesday, December 6, 2023 at 6 p.m. All community members will have the opportunity to share feedback about this proposal at the Joint Public Hearing, which will begin at 6 p.m.

This proposal must be voted on and approved by the PEP prior to implementation. We anticipate that the PEP will vote on this proposal on Wednesday, December 20, 2023 at 6 p.m. at M.S. 131, located at 100 Hester Street, New York, New York 10002. Feedback about this proposal may also be shared at the December 20, 2023 PEP meeting.
